Celebrating 80 years of diplomatic relations in 2024, Canada and Mexico have cultivated a robust trade and investment partnership. Since NAFTA's implementation in 1994, and further strengthened by CUSMA, bilateral trade has increased. '22 MEX imports to Canada \$40.6B, goods exports to Mexico \$9.1B. Mexico is now Canada's third-largest trading partner, while Canada ranks fourth for Mexico. With \$40.4 billion in Canadian direct investment, Mexico is a key destination. Export Development Canada (EDC) has prioritized Mexico, operating a regional office since 2000 to support Canadian exports and investments. Key commodities of trade include delivery trucks, motor vehicles; parts and accessories, spark ignition engines, tractors, broadcasting equipment, medical instruments and tropical fruits. In the agri-food sector, Mexican exports of tomatoes, guavas, peppers, Ataulfo mangoes, avocadoes and berries and spirits.

As a steadfast ally, Canada was the first Western nation to recognize Ukraine's independence and has been a leading voice in international support for Ukraine since Russia's illegal invasion in 2014. With a significant Ukrainian-Canadian diaspora of 1.3 million, our bilateral relationship is deeply rooted in shared values and history. In 2023, Canada's trade with Ukraine reached \$695.4 million, with key exports including military equipment and machinery, and key imports comprising sunflower seeds and oils, uranium, and electrical equipment. The Canada-Ukraine Free Trade Agreement (CUFTA), in effect since 2017, further strengthens our economic ties. Canada remains committed to supporting Ukraine's sovereignty and territorial integrity against Russia's ongoing aggression.
